## Interrelationship of building and surroundings

Less than half a mile to the west is the Guilford Green. Surrounding the property are eighteenth, nineteenth, and early twentieth century single-family dwellings.

## Other notable features of building or site

An addition is added to the south elevation of the house, and on the west elevation are two-story bay windows. Fenestration includes two-over-two double-hung windows.
