• Interrelationship of building and surroundings:

This property consists of 0.25 acres of land on the south side of Edwards Street. A driveway extends to the west off Dohm Avenue and terminates in front of (to the east of) the garage. The attached garage is to the south of the house. The property is on the corner of Edwards Street and Dohm Avenue. Less than a mile to the south is Nut Plains Cemetery and a mile to the northwest is Guilford Lakes Elementary School. (See continuation sheet)

• Other notable features of building or site (Interior and/or Exterior)

This is a one-story, side-gable Colonial Revival cape style dwelling. It is sheathed in wood shingle siding with asphalt shingles on the roof. A brick chimney protrudes from the center of the ridgeline of the roof. The facade faces north and the main entry is centered on this side in a vestibule. It is reached by concrete stairs with no railings. The door includes a simple door surround with square pilasters and a narrow entablature. (See continuation sheet)

Architect _____ Builder Edward Dohm (Helander)

• Historical or Architectural importance:

According to a 1948 Developer's Map of Edwards Street and Dohm Avenue found at the Town Clerk's office, this house was built before the map was created. This street was developed by Edward and Anna Dohm in the late-1940s. The houses were built between 1947-1956 (Helander). Originally this subdivision was named "Ridgecroft," but it is now known by residents as "Dohmville." Edward Joseph Dohm was born in New York in 1913 to Julius and Theresa Dohm. He married Anna Russo in 1940. He was a developer who owned his own construction company, Dohm Construction Company. He died at the age of 83 in 1996. Anna Russo was born in New Haven in 1916 to Pasquale (an Italian immigrant) and Antoinette Basilicato Russo, Sr. (See continuation sheet)

Interrelationship of building and surroundings

Surrounding the property are twentieth century single-family dwellings.

Other notable features of building or site

A garage is attached to the house by a breezeway extending to the south off the south elevation of the house. Fenestration includes eight-over-eight double-hung windows. Additions are attached to the east and west elevations of the house.

Historical or Architectural importance

The Russos moved to Guilford and lived on Nut Plains Road when Anna was 17. Anna Russo was the oldest of ten children. She was very active in sports and played on semi-pro basketball and baseball teams. She was also a model for the Sun Beam Dress Factory. She died in 2008 and is buried at the Alderbrook Cemetery. The owner in 1954 was Sherman Wilson. He sold the property in 1964 to Alvin and Janet Thomas. John Gourlie purchased the property in 1975, and in 1984, it was acquired by Faye Gourlie. Peter Stevenson purchased the property in 1989.
