SIGNIFICANCE

9. ARCHITECTURAL-HISTORICAL
A house belonging to J. Frisbie is shown on or near this site on a map of 1852, and a house belonging to H. Martin is shown on or near this site in 1868. It is not clear if they are the same house, or, if not, which one is this one. In other words the present house may be a Greek Revival design of the 1840s (of which it would be a quite characteristic Guilford specimen) to which a two-decker bay and fancy porch were added probably c1865-70, or it may be a new house of probably c1865-70 which makes use of a conservative Greek Revival main block and dresses it up with the latest style in bay windows and porches--this too would be a characteristic thing for Guilford to do.

This was one of the few farms south of Henry Whitfield's estate.
